Working in coordination with a network of offices, chapters, and supporters throughout the region and affiliated organizations around the country, the ANCA-Western Region serves all aspects of the Armenian Cause by organizing and developing local Armenian communities; promoting the political, legal, socioeconomic, cultural, and educational interests and rights of the Armenian American community at the local, state, regional, and national levels; seeking justice for the Armenian Genocide; advocating for the sovereignty, independence, democracy, security and economic development of the Republic of Armenia; advocating for the right of return, self determination, security and independence for the people of Artsakh; advocating for the protection and cultural preservation for the Armenians of Javakhk; and advocating for all aspects of the Armenian Cause through grassroots mobilization, political relationships, media presence, and education.

ANCA-WR Board of Directors Message from the Chair

Dear ANCA WR Supporter,

The past few years have proven to be a consequential time in the long history of the Armenian Nation. From the devastating 44-Day War in Artsakh in 2020 to the nearly 10-month illegal and inhumane blockade of Artsakh starting in December 2022, to the military assault on Artsakh which led to the forced depopulation of over 120,000 Armenians in September 2023, the pan-Turkic genocidal plan to ethnically cleanse this historically Armenian land from its indigenous people came to fruition, leaving our nation reeling and traumatized.

Indeed, these are hard times in so many ways. The world is an unjust place, as geopolitical interests routinely trounce noble aspirations of human rights, freedom and justice. Tyrannical regimes act with impunity as they take advantage of rampant indifference and refusal of the international community to act to protect humanity. It is difficult to decipher political loyalties, as our allies not only enable but even support our enemies, either playing both sides or outright abandoning us in our time of dire need.

In the face of this tremendous loss, it is certainly easy to fall into a sense of hopelessness and despair. But as we meet the daunting challenges and existential threats that face us, we must remind ourselves that the Armenian Nation throughout history has repeatedly risen from the ashes of the worst calamities, resilient and resolute; that from adversity comes strength, and clarity of purpose.

As the largest and most influential grassroots advocacy organization in the western half of the United States and as a leading voice of the Armenian-American community, the ANCA Western Region is here to reaffirm that we will not be silenced, and we do not cower in the face of aggression by Azerbaijan, Turkey or anyone else.

Our overriding mission now must be to defend and protect Armenia and the rights of Armenians everywhere.

Now more than ever, we know that Armenia can only survive if it is left in peace. But we also know that true peace entails not only the absence of war – but the presence of justice. And that justice, for us, includes accountability for crimes against humanity by both Azerbaijan and Turkey; secure borders; the right of Artsakh Armenians to return to their ancestral home; an international protectorate to ensure their safety, freedom and preservation of culture; and the safe return of all prisoners of war and unlawfully detained persons.

Here in the United States, as American-Armenians, it is our right and indeed our duty to demand that our government move beyond supportive rhetoric to solid action to achieve this justice. We need the U.S. foreign policy establishment to recognize that in its efforts to ensure a just and sustainable framework for peace in the Caucasus, it is in the U.S. strategic interest to give Armenia a viable option for strategic realignments, and to actually be a genuine ally whose support for Armenia is tangible, steadfast and reliable.

This is our mission, and these are our priorities moving forward as we rise from the aftermath of seismic shifts which have devastated all of us.

On behalf of our Board, I want to thank each of our volunteers, our Staff, our local chapters, committee members, activists, and especially our donors, for without your encouragement and unwavering and generous support, we would not be able to do the important work we do every single day to amplify our message in the halls of government, in the world of media, and in the broader public sphere. We cherish the partnership and collaboration we have with every single elected official, honoree, donor, volunteer and coalition partner as we all work collectively together toward our common goal of justice for the Armenian Nation.

So through both these hard times and the better days ahead, we will see you in the trenches.

Promoting a Sister-State Relationship Between California and Syunik

In light of Azerbaijan's occupation of the sovereign territories of the Republic of Armenia since May 2021, especially in the provinces of Gegharkunik, Vayots Dzor and Syunik, ANCA-WR advocated for the establishment of a sister-state relationship between the State of California and the Province of Syunik. In February 2022, through the passage of CA State Senate resolution ACR 105 (Holden), a sister-state relationship was established to facilitate mutually beneficial educational, economic, and cultural exchanges.

Azerbaijan's 2022 102. Invasion of Armenia and its Aftermath

Azerbaijan has continuously invaded and occupied the sovereign territories of the Republic of Armenia since May 2021, but on September 13, 2022, Azerbaijan launched a full-scale attack on sovereign Armenian lands causing extensive damage to civilians and civilian infrastructure in the border communities of the Syunik, Vayots Dzor, and Gegharkunik provinces. According to official reports, at least 135 Armenians were killed, and more than 7,500 civilians were internally displaced. including women, children, elderly, and disabled persons. Furthermore, Azerbaijan's extensive targeting of civilian infrastructure resulted in heavy damage to more than 200 residential structures-upwards of 50 of which were damaged or including school buildings. destroyed. government administration buildings, a medical center, and a gas supply pipeline. During this invasion, Azerbaijan also opened fire in the direction of journalists from both foreign and Armenian media outlets, despite the clear display of "press" emblems.



Speaker Nancy Pelosi's Visit to Armenia

On September 18, 2022, a US Congressional delegation led by then-Speaker Nancy Pelosi arrived in Armenia with the aim of deterring further Azerbaijani aggression against the Republic of Armenia. The delegation included Rep. Jackie Speier, Rep. Anna Eshoo and Rep. Frank Pallone. ANCA-WR welcomed the delegation's visit and submitted a list of demands to the US Congress and the Biden Administration. On September 25, 2022, ANCA-WR hosted a press conference in Los Angeles featuring Rep. Jackie Speier where she briefed Armenian and non-Armenian media about the delegation's data gathering mission and the outcome of the meetings held with representatives of the Armenian Government.

ANCA-WR with Artsakh Foreign Minister David Babayan

From September 15-28, 2022, <u>upon the invitation of the ANCA-WR, then Foreign Minister David Babayan led a Republic of Artsakh delegation tour of the United States</u> to participate in high level meetings with several US Members of Congress in both Washington DC and California, including Rep. Adam Schiff, Rep. Brad Sherman, Rep. Judy Chu, Rep. Jackie Speier, Rep. Jim Costa, Rep. Frank Pallone, Rep. David Cicilline, as well as attend meetings with state and local officials and participate in events featuring Armenian community members and organizations.

In California, the delegation which included Deputy Minister of Culture and Youth of Artsakh Dr. Lernik Hovhannisyan and Artsakh's Permanent Representative in the US Robert Avetisyan met with California State Senator Anthony Portantino, Assemblymember Adrin Nazarian, and LA County Supervisor Kathryn Barger who presented an LA County Board of Supervisors' scroll to David Babayan, only a few months after the LA County Board of Supervisors had rescinded a scroll erroneously issued to outgoing Azerbaijani Ambassador Nasimi Aghayev.

Furthermore, Babayan delivered a powerful speech at LA City Council where he met with LA City Council members and held a joint press conference with then LA City Councilmembers Paul Krekorian and Paul Koretz. The delegation also visited Glendale City Council where they met with City Council members and other officials, and David Babayan signed an MOU with then Glendale Mayor Ardy Kassakhian setting the parameters of cooperation between Glendale and Martuni (Artsakh) after Glendale City Council had unanimously voted to establish a sister-city relationship between Glendale and Martuni on August 23, 2022.

The ANCA-WR is working closely with Rep. Schiff to ensure the passage of H. RES. 861, has launched an online campaign #FreeArmenianHostages, and is doing everything possible to exert pressure on all fronts to secure the release of all Armenian POWs, hostages, and other illegally detained Armenians.</u>

2022 ANCA Western Region Grassroots Conference

On September 24, 2022, hundreds of community leaders, advocates, youth, media personnel, scholars and activists gathered for the 6th biennial ANCA-WR Grassroots Conference dedicated to Artsakh.

The conference featured experts from Armenia, Artsakh, and the United States in the fields of international law, politics, genocide studies, and international human rights and humanitarian law focusing on strategically designed panels: (1) "Prevention of Cultural Genocide," (2) Q&A with Dr. Arman Tatoyan, (3) Keynote Speech by then Artsakh Foreign Minister Dr. David Babayan; and (4) "International Justice" presentation and discussion featuring three members of the Republic of Armenia's legal team at the International Court of Justice.

Azerbaijan's Illegal 106. Blockade & Genocide of Artsakh

The 2020 Artsakh War waged by Azerbaijan backed by Turkey and Syrian mercenaries resulted in the occupation of Hadrut. Shushi. Qashatagh, and Shahumyan by Azerbaijan, the displacement of more than 30,000 Artsakh Armenians as refugees, the signing of the trilateral statement, the withdrawal of Armenia's forces from Artsakh and the deployment of Russian Peacekeepers.

However, less than a month after the conclusion of the 2020 War on Nov. 9, 2020, Azerbaijan resumed its assault against the Armenians of Artsakh under the watchful eyes of the Russian peacekeepers and the international community. After nearly two years of inaction by the international community, on December 12, 2022, Azerbaijan illegally blockaded the remaining 120,000 Armenians of Artsakh using pseudo-environmentalists as a false pretense for their illegal and inhumane action.




Our Immediate Efforts

ANCA-WR immediately intensified its efforts to prevent the ethnic cleansing/genocide of Artsakh by advocating at all levels of government (local, state, federal), including the Biden Administration, State Department Officials, USAID officials. launching online campaigns and mobilizing the Armenian American community by collaborating with dozens of Armenian organizations including members of the Pan-Armenian Council Western USA, ensuring media coverage of the humanitarian crisis caused by Azerbaijan's illegal blockade, creating coalitions with non-Armenian partners, and organizing press conferences and community events.

Demand US Action for Azerbaijan's Campaign of Genocide in Artsakh

On December 21, 2022, in collaboration with the PAC-WUSA. ANCA-WR called upon President Biden. Secretary of State Blinken. National Security Advisor Sullivan, and USAID Administrator Power to condemn Azerbaijan's illegal blockade and ongoing aggression against Armenia and Artsakh, to demand the immediate opening of the Lachin Corridor, to deliver \$100 million in humanitarian aid to the Armenians of Artsakh, to sanction the Alivey regime for its war crimes and to introduce a UN Security Council resolution to establish a UN Mission to protect Artsakh.

In January 2023, ANCA-WR launched the #SaveArtsakh online letter campaign to enable Armenian Americans to submit letters to the Biden Administration with the aforementioned demands and successfully secured the support of coalition partners including the Asian-American National Committee. Assyrian American Association of Southern California, Inner City Struggle, Israeli American Civic Action Network, Jewish World Watch, Muwekma Ohlone Tribe and other non-Armenian coalition partners in submitting similar letters to the administration.

On February 6, 2023, ANCA-WR hosted a packed Town Hall meeting with then State Minister of the Republic of Artsakh Ruben Vardanyan, who joined virtually from behind the blockade in Artsakh, to update the community about the humanitarian crisis on the ground. Congressman Adam Schiff also joined virtually to reiterate his commitment to the Armenian community both in the United States and abroad, and described his recent and ongoing initiatives in getting U.S. and international attention toward alleviating the blockade.

At the invitation of ANCA-WR, Hon. Robert Avetisyan, Permanent Representative of Artsakh in the United States, attended the Town Hall hosted in Glendale in-person and was then invited by Rep. Schiff to attend the State of the Union Address by <u>President Biden</u> on February 7, 2023 as his guest.

<u>State Minister Vardanyan briefed the Los Angeles community about the consequences of Azerbaijan's blockade</u> and warned that there is no scenario under which Armenians can ever live in peace under Azeri rule.

Over the course of the ensuing months, <u>ANCA-WR worked with media consultants</u>, researchers, human rights experts, and journalists to secure local, national and international media coverage of the humanitarian crisis in Artsakh caused by Azerbaijan's illegal blockade of the Lachin Corridor. The organization held off-the-record discussions with Former ICC Prosecutor Luis Moreno Ocampo, David Ignatius of the Washington Post, Nicholas Kristof of the New York Times, Michael Rubin of the American Enterprise Institute, collaborated with local journalists <u>Araksya Karapetyan</u> and Christina Pascucci of Fox 11 and Ellina Abovian of <u>KTLA</u>, and briefed researchers at Human Rights Watch.

Joint Letter Calling On the Biden Administration to Take Immediate Action in Response to Azerbaijan's Illegal Blockade of Artsakh







ANCA WR and Coalition Partners sent a letter to President Biden Demanding Immediate action to end Azerbaijan's illegal blockade of Artsakh.

In August 2023, in collaboration with the other members of the PAC-WUSA, the organization held a press conference in front of the Azerbaijani Consulate General in Los Angeles featuring Congressmen Adam Schiff and Brad Sherman, and Los Angeles City Council President Paul Krekorian; Glendale Mayor Dan Brotman and Glendale City Councilmember Ardy Kassakhian, Los Angeles City Councilmembers Heather Hutt and Traci Park, as well as former California Assemblymember Adrin Nazarian.



PAC WUSA hosted a press conference in front of the Azerbaijani Consulate in Los Angeles featuring elected officials to call upon the Biden Administration to stop Azerbaijan's illegal blockade of Artsakh.

All speakers echoed PAC-WUSA's demands calling on the Biden Administration to introduce a resolution in the UN Security. Council that would force Azerbaijan to lift the blockade and end the humanitarian crisis in line with the ICJ ruling ordering Azerbaijan to open the Lachin Corridor, immediately halting all U.S. military assistance to Azerbaijan consistent with Section 907 of the FREEDOM Support Act, sanctioning members of the Aliyev regime under the Global Magnitsky Human Rights Accountability. Act for ongoing war crimes, delivering \$100 million in USAID humanitarian assistance to Artsakh, and introducing a UN Security Council resolution to establish a United Nations Mission in Artsakh (Nagorno-Karabakh) [UNMINK] consisting of 5,000 international military personnel to ensure the physical security of the population.

Despite a preliminary measure issued by the International Court of Justice ordering Azerbaijan to end its illegal blockade of Artsakh in February 2023 and numerous warnings by international law experts like Luis Moreno Ocampo, the former prosecutor of the International Criminal Court, about the Second Armenian Genocide in Artsakh, the inaction of the international community during the 282 days of the illegal blockade created an environment of impunity that culminated in Azerbaijan's September 19, 2023 full scale military offensive against the 120,000 Armenians of Artsakh. The military offensive aimed to complete the genocidal campaign of the Alivey regime by ethnically cleansing all Armenians from their ancestral lands in Artsakh. After a 24-hour full-scale offensive that resulted in the death of hundreds of Armenians, including women, children, and elderly, the Artsakh government was coerced into agreeing to a ceasefire to spare the lives of the 120,000 Armenians of Artsakh.

The September 19, 2023 offensive came five days after a US Senate Foreign Relations Committee hearing where acting Assistant Secretary of State Yuri Kim stated: "The Lachin Corridor must be open now, now...No more delay... We will not tolerate any attack on the people [Armenians] of Nagorno Karabakh..." and under the watchful eyes of the Russian peacekeepers who were deployed in Artsakh to protect the civilian Armenian population.

Political Advocacy & Government Affairs

At the local level, ANCA-WR has advocated in 2022-2023 for the passage of numerous resolutions and motions in support of the sovereignty and territorial integrity of Armenia, <u>defense of Artsakh</u>, <u>as</u> well as other issues of concern to the Armenian American community.

In June 2022, ANCA Western Region worked with Assemblymember Kevin McCarty to include the Republic of Artsakh in AJR-34, the World Refugee Day resolution, which honors the world's displaced peoples. This legislative push faced heavy backlash from then-Azeri Consul General Nasimi Aghavev, who threatened to undermine US-Azeri relations if Assemblymember McCarty retained the language recognizing the status of the people of Artsakh as displaced persons caused by Azerbaijan's 2020 War. ANCA-WR advocates helped facilitate passage of AJR 27 (Asm. Nazarian) and SR-82 (Durazo), which recommitted the State of California's pursuit of recognition and remembrance of the Armenian Genocide, culminating in the passage of AB1801 (Nazarian), which codifies April 24th as a bank holiday across the state of California. ANCA Western Region worked tirelessly with Asm. Nazarian's office to ensure that a holiday on April 24th will serve to advance the conversation about the Armenian Genocide, cultivating new opportunities for the Armenian-American community to engage with non-Armenians and educate them about the crimes committed by Turkey.





Moreover, ANCA-WR worked closely with CA State Senator Scott Wilk to ensure the passage of SB 1089, which extends the sunset clause for Asm. Nazarian's AB 1320, which prohibited public pension investments made by Turkish-government-backed securities, initiated by any formal sanctions or policies by the United States government. Finally, <u>ANCA-WR successfully led the Armenian American community's effort</u> to pass an LA County Board of Supervisors Motion introduced by <u>Supervisors Barger and Horvath condemning Azerbaijan's illegal blockade of the Lachin Corridor</u> and led the advocacy efforts to ensure the passage of <u>AJR-1 by the California State Assembly (March 2023)</u> and <u>Senate (July 2023)</u>.

Advocating for an Armenian Checkbox on the 2030 Census


Between February and May 2023, ANCA-WR in collaboration with the Armenian American Action Network and the participation of many members of the PAC-WUSA secured and submitted support letters from dozens of elected officials to the Office of Management and Budget urging the inclusion of a Middle Eastern and North African checkbox with an Armenian subcategory checkbox on the 2030 United States Census questionnaire.

ANCA-WR and the Armenian American Action Network also mobilized a community-wide effort for the submission of individual letters and comments by Armenian Americans via OMB's website, resulting in the submission of more than 1,800 comments in favor of the inclusion of an Armenian sub-category checkbox on the 2030 United States Census questionnaire from a total of 20,250 submitted comment by various ethnic groups from across the United States. Securing the identification of Armenians as an ethnic minority in the United States will open doors to a vast array of public grants and security protections for our communities throughout the country and is vitally important for the future of our Armenian-American institutions.









During the California Redistricting process, the ANCA-WR - through mobilization of the community - was able to reverse some of the most damaging proposals put forward by the Los Angeles City Council Redistricting Commission.



Meetings and Endorsements

In 2022 and 2023, ANCA Western Region Board members, staff, local chapter members and committee members held dozens of meetings with elected officials to endorse candidates worthy of the support of the Armenian-American community and to advocate for the prevention of genocide in Artsakh, the restoration of Armenia's territorial integrity and protection of its sovereignty, and the advancement of Hye Tahd priorities on the local, state, and federal levels.

O8. ANCA Western Region Education Committee

On the Federal level, ANCA Western Region's Staff and Education Committee members advocated for the passage of H. Res. 7555 (Rep. Maloney) that aims to allocate \$10 million over 5 years to the Library of Congress for the development and national dissemination of accurate, relevant, and accessible resources to promote public understanding of the Armenian Genocide. The ANCA-WR Education Committee held a <u>virtual Armenian Genocide Education Committee Luncheon in 2022</u> and an <u>inperson one in 2023</u>, during which distinguished honorees were recognized for their commitment and innovative efforts to teach about the Armenian Genocide.



In 2022 and 2023, ANCA-WR's Education Committee also collaborated with Kelly Gonez, a member of the LAUSD Board of Education representing Board District 6, to host training sessions on Armenian Genocide for L.A. Teachers and Families and to create a comprehensive K-12 Teacher's Guide of resources and frameworks to help educators teach about the Armenian Genocide. Moreover, the ANCA-WR Education Committee, in April 2022, ensured that more than 3 million National Education Association (NEA) members received an informational sheet and a digital guide to incorporate the Armenian Genocide in classrooms. The National Education Association is the largest education labor union in the United States. It represents public school teachers, faculty and staffers at colleges and universities, retired educators, and college students preparing to become teachers. The NEA has affiliate organizations in every state and in more than 14,000 communities across the United States.

19. Hye Votes Campaign and Investing in the Next Generation

Launched in 2012 by the ANCA Western Region and successfully registering tens of thousands of new voters in the ensuing years. Hye Votes is a region wide, non-partisan initiative designed to encourage civic engagement in the electoral process.

During the 2022 Midterm Elections, HyeVotes worked with local Armenian television stations to release and promote videos and PSAs featuring community leaders and elected officials who focused on the importance of voting. Volunteers conducted phone banking and canvassing to relay important information regarding the elections and provided voter assistance to community members.

In 2023, ahead of a special election held for the Los Angeles City Council District 6, the organization held a HyeVotes Candidate Forum for the two Los Angeles City Council District 6 candidates in which over 100 prospective voters participated.




Duty to Prevent (D2P)

ANCA Western Region's Duty to Prevent (D2P) Initiative was launched in 2021 in response to the alarming escalation of Armenophobic crimes and incidents around the world.

For centuries, Armenians have been a target of persecution, ethnic cleansing, and genocide for their ethnic and religious identity. Armenophobia is unfortunately a growing phenomenon in today's world – particularly in Turkey and Azerbaijan – where propagation of hatred towards Armenians has been a longstanding state-sponsored policy. This state-sponsored hate policy has morphed into other regions with numerous anti-Armenian incidents taking place in Armenian populated regions across the United States and Europe.



In 2024, ANCA WR plans to work closely with the Ombudsmen of Armenia and Artsakh, the representative of the Republic of Armenia on international legal issues and other leading human rights and humanitarian rights experts who are combatting Armenophobia to develop a comprehensive definition of Armenophobia that can be applied universally. A universal definition of Armenophobia is required to combat hate speech and practice induced by Turkey and Azerbaijan, as well as defending local communities in the US, Europe, and beyond from anti-Armenian sentiments.
